1. ONLY HANDMADE/HAND-CRAFTED ITEMS MADE BY THE EXHIBITOR ARE ALLOWED. THIS WILL BE STRICTLY ENFORCED. YOU MAY NOT DISPLAY OR SELL THE FOLLOWING:

FLEA MARKET MERCHANDISE RUMMAGE COMMERCIAL COSMETICS COMMERCIAL KITS

LIVING PLANTS FISH OR OTHER LIVE ANIMALS

MANUFACTURED ITEMS FROM WHOLESALE OUTLETS

ITEMS PURCHASED FROM ANOTHER VENDOR

- 2. LIMITED DIRECT SALES VENDORS, NO DUPLICATES, SUBJECT TO BOARD APPROVAL.
- 3. BOOTHS ARE RESERVED AND NO EXCHANGES ARE ALLOWED.
- 4. NO POLITICAL ACTIVITIES, RAFFLES, OR LOTTERIES ARE ALLOWED.
- 5. NO SMOKING, NO HEATERS, AND NO LIT CANDLES.
- 6. NO ALCOHOLIC BEVERAGES ARE ALLOWED ON THE PREMISES.
- 7. EXHIBITORS ARE REQUIRED TO STAY THE FULL TIME OF THE SHOW. ANYONE LEAVING EARLY EITHER DAY WILL NOT BE INVITED TO RETURN NEXT YEAR. IF YOU HAVE AN EMERGENCY, PLEASE CONTACT THE FRACA DIRECTORS TO MAKE ARRANGEMENTS.
- 8. YOUR TABLES MUST BE COVERED TO THE FLOOR. PLEASE BE CONSIDERATE OF YOUR NEIGHBOR AND DO NOT EXTEND YOUR TABLES OR DISPLAYS INTO ANOTHER VENDOR'S SPACE.
- 9. THE BOARD OF DIRECTORS RESERVES THE RIGHT TO ASK AN EXHIBITOR TO LEAVE THE SHOW IF THEIR BOOTH EXHIBIT ITEMS ARE NOT IN ACCORDANCE WITH THE FESTIVAL STANDARDS.
- 10. CAMPING IS ALLOWED ONLY IN THE CAMPGROUND AREA LOCATED BEHIND THE FAIRGROUNDS. CONTACT THE DUBOIS COUNTY 4-H FAIRGROUNDS FOR DETAILS, INCLUDING FEES.
- 11. NO PETS ARE ALLOWED IN BOOTHS OR UNRESTRAINED ON THE GROUNDS.
- 12. THE BOARD OF DIRECTORS RESERVES THE RIGHT TO REJECT ANY APPLICATION AND RETURN THE ENTRY FEE.
- 13. ALL EXHIBITORS MUST VACATE THE BUILDINGS AND GROUNDS BY 6:00 PM EST ON SUNDAY.
- 14. NO PICTURES OR VIDEOS ARE ALLOWED WITHOUT VENDOR PERMISSION.
- 15. FOUR RIVERS ARTS & CRAFTS ASSOCIATION IS NOT RESPONSIBLE FOR LOST OR STOLEN ITEMS.
- 16. VENDORS MAY NOT ENGAGE IN "HAWKING" OR ATTRACTING CUSTOMERS OUTSIDE YOUR BOOTH AREA BY CALLING OUT TO PEOPLE. THE USE OF LOUD MUSIC, SPEAKERS, MEGAPHONES, OR ANY OTHER ACTIONS THAT LEGITIMATELY DISTURB NEIGHBORING VENDORS OR THE GENERAL PUBLIC ARE PROHIBITED.
